# Medical Debt In New York #EndMedicalDebt



#### Medical debt is a crisis nationally and in NY

- 7 out of every 10 New Yorkers are worried about paying their bills; 41% have appealed a bill or paid one they didn't think they owed because they were afraid of debt collectors
- CHA has seen a 64% increase in medical debt case


#### Hospitals have sued 53,000 New Yorkers


- Average lawsuit is for \$1,900
- Filed liens on people's homes, garnished thousands of wages
- Patients sued during the pandemic
- Data indicates low-income patients and patients of color are targeted for medical debt actions


Many hospitals never sue at all

# Half of New Yorkers express uncertainty about paying for usual healthcare services; 7 in 10 aren't very confident about paying for costs related to a major illness.

Q: Generally speaking, how confident are you that you have enough money or health insurance to pay the medical costs for the USUAL healthcare services that you or your family require?

### Medical debt is a public health concern for low-income & minority patients

- JAMA (2021); CFPB (2022)
  - Medicaid debt disparately impacts patients who are low-income and/or people of color
- Discharged Into Debt series of reports revealed:
  - Pandemic (1/21): Hospitals sued 5,000 New Yorkers during the pandemic
  - Racial Disparities (3/21): Significant racial disparities in medical debt
    - 200-400% more common in majority minority zip codes (Westchester, Albany, Monroe, Onondaga, Erie, and Schenectady counties)
    - Albany:
      - 65% of lawsuits filed in zips w/high proportion of people of color
      - 50% of lawsuits filed in zips where median family income is less than 200% of the FPL, which is far below the income cutoff under the State's hospital financial assistance law










# The relationship between medical debt and housing insecurity

- Discharged Into Debt: Nonprofit Hospitals File Liens on Patients' Homes (11/21)
- 56 hospitals filed a total of 4,880 liens between 2017 and 2018 – while getting \$442 million in State ICP funds
- A judgment lien can reduce the value of what is, for most people, their main asset and future economic security\*

# **Medical Debt on Long Island**



- Long Island is a medical debt "hot spot"
  - More lawsuits are filed in Long Island than in any other region of the state (outside of Syracuse)
- Between 2015-2020, non-profit hospitals on Long Island sued 18,275 patients
  - Northwell & NYU Winthrop sued the most patients
- Northwell sued patients during the pandemic (March December 2020), when the courts were effectively closed to the public
  - 1,500 patients in Suffolk
  - 700 patients in Nassau

## The #EndMedicalDebt Package



### ✓ Passed & signed

- ✓2021: Judgment interest rate reduced from 9% to 2% for consumer/medical debt
- ✓ 2020: Statute of limitations reduced from 6 to 3 years for medical debt

### ✓ Passed & signed

- ✓ 2022: Ban Medical Liens and Wage Garnishments for medical debt
- **✓ 2022: Regulate Facility Fees**

Make New York the first state to ban facility fees for preventive care and tell patients about them beforehand.

#### **TO DO in 2023**

✓ Ounce of PreventionAct: ModernizeHospital Financial Aid

Patients are being sued and placed into collections because it is too hard for patients to find out about and apply for the assistance they qualify for.

### **Ounce of Prevention Act**

S7625A/A8441A



#ENDMEDICALDEB

- NY hospitals are non-profits & get \$1.1 billion annually to offer Hospital Financial Assistance
  - So why are so many people being harassed and sued?
- Ounce of Prevention Act S7625A/A8441 would:
  - Create 1 common application form
  - Simplify and increase income eligibility limits
  - Eliminate obsolete rules and streamline applications

# **End of the Public Health Emergency**

- Public Health Emergency Response to COVID pandemic
  - Suspension of renewal requirements for public coverage, including Medicaid, Child Health Plus, Essential Plan
  - 9 million New Yorkers have this coverage
  - New York State has 1 year, beginning April 2023 to renew its public insurance enrollees
    - NYSOH notices will start in May 2023
    - Long Island (Upstate WMS) notices will start in April 2023
    - NYC notices will start in March 2023
  - Everyone will be renewed by June 2024
