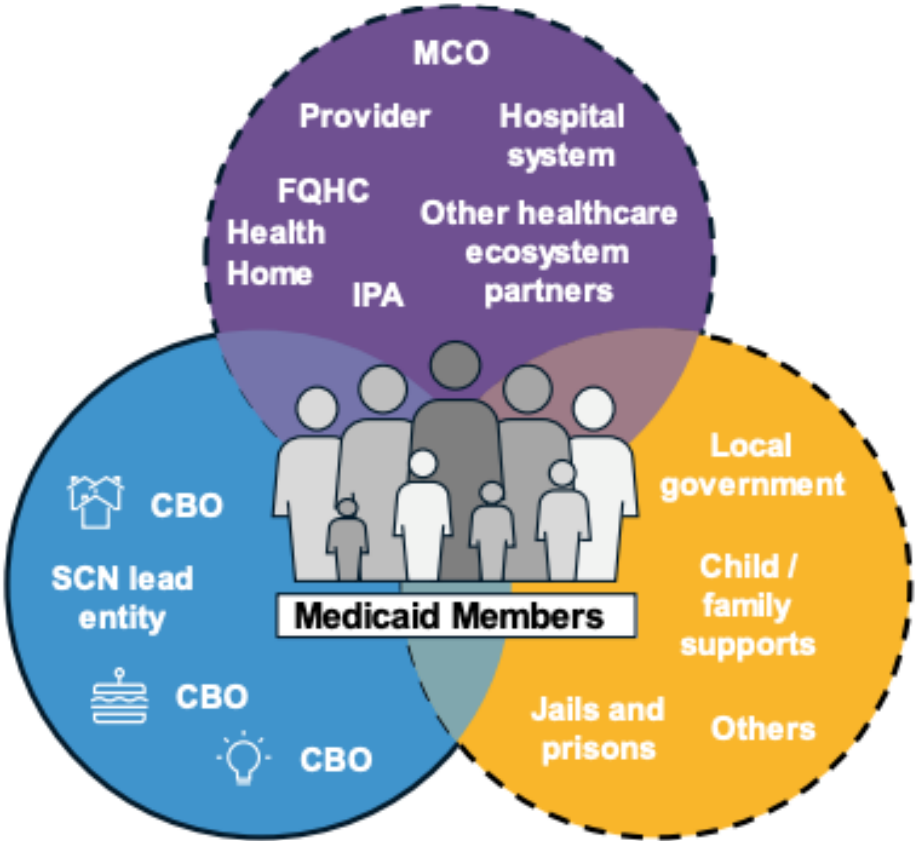
Infrastructure Funding to Be Used For:

 - Training and technical assistance
- SCN network development and engagement
 - Ensure network adequacy to reach Medicaid members with an equity lens
- Technology and data analytics
- Contracting and Fiscal Management

SCN Timeline

- SCN RFA responses due April 5, 2024
- Awards expected June 1, 2024
- State funding for SCNs to begin August 1, 2024
- SCN stands-up operation January 2025
- Waiver period ends March 31, 2027

Impact of future state system on Medicaid members

- Scaled delivery** of social care services and **improved access** for Medicaid members
- Reliable and timely referral** of members to social care services
- Seamless tracking** of members needs to streamline and close loop on referrals to social care services
- Improved and increased collaboration** between social care service providers and other partners in regional ecosystem (e.g., healthcare providers, care management providers, MCOs, others)

 - NYS 16.4%

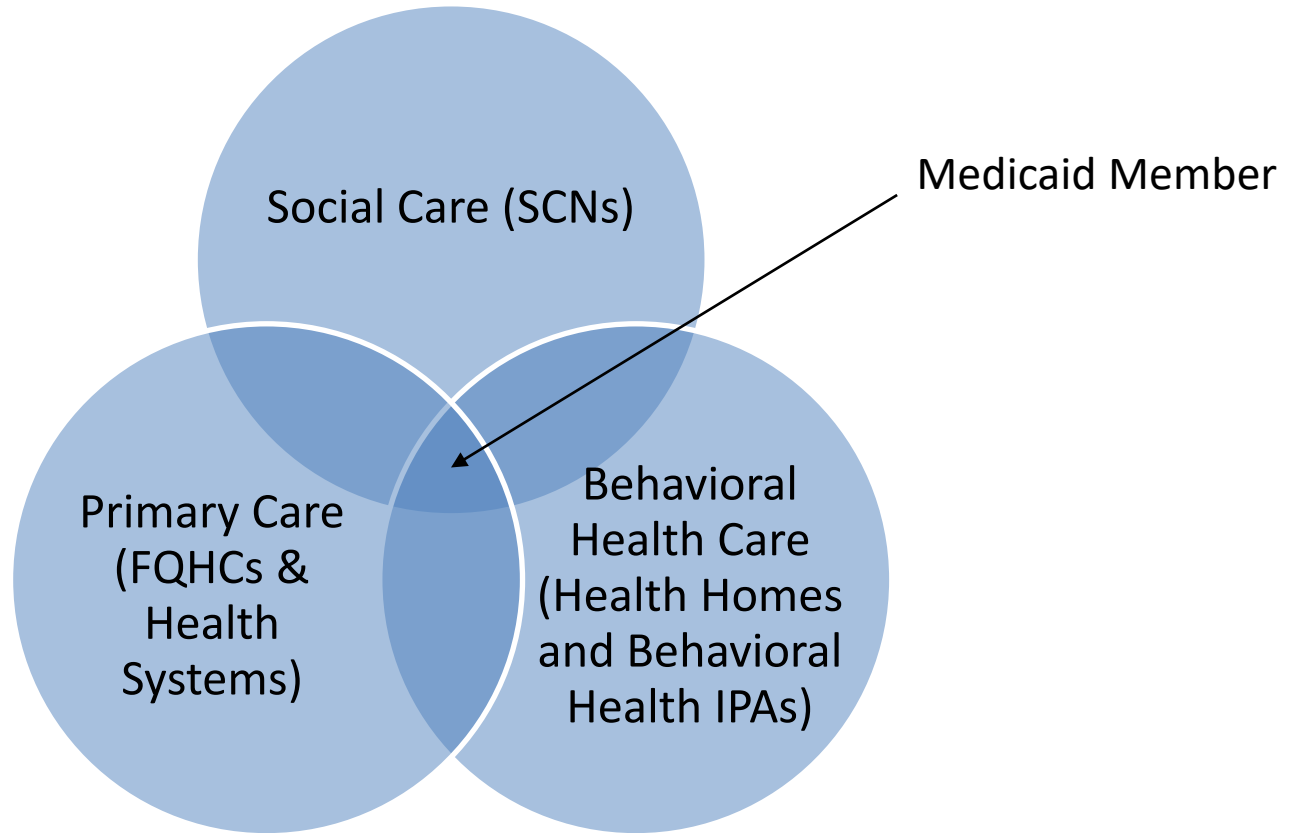

National Academies of Sciences, Engineering, and Medicine (NASEM) report *Implementing High-Quality Primary Care: Rebuilding the Foundation of Health Care*

High-quality primary care in the United States recommendations:

- Pay for primary care teams to care for people, not doctors to deliver services.
- Ensure that high-quality primary care is available to every individual and family in every community.
- Train primary care teams where people live and work.
- Design information technology that serves the patient, family, and interprofessional care team.
- Ensure that high-quality primary care is implemented in the United States.
